**Friends and Family Sponsorships:** Ben and Becca Norris are leading this year's Friends and Family Sponsorships component of Maury at the Market. This is a way we encourage our friends and family to donate to Maury, and was a significant part of our fundraising effort in 2019. **Local School Advisory Team (LSAT):** Jean Kohanek announced that the Mayor's budget proposal for next school year was released just before the PTA meeting. Jean noted that LSAT would be meeting imminently to discuss how to allocate this budget. Jean explained that Maury has received a funding increase, which is reflective of our student population growth.

**School Equity Group:** Jean Kohanek explained that this new Maury effort is intended to spark community discussions and to improve the sense of community at Maury and address equity issues in the school community. Participating is a great opportunity to share your experience at Maury and to hear from others. The sessions are to encourage everyone to share what, in their view, is good and what is challenging.

#### Principal's and Assistant Principal's Updates

---

**PARCC:** Assistant Principal Griffin announced that all DCPS schools are scheduled to take PARCC this spring, sometime between late March and late April. It's looking likely the testing will take place. The Office of the State Superintendent (OSSE) did not apply for a waiver to exempt students from testing; therefore, as of right now, we are on track to take PARCC this spring. This isn't a decision that happens at the school level, but rather at the district level.

This will be the first time the school administers PARCC in a virtual and in a socially-distanced setting (testing was canceled last school year). The PARCC was adopted by DCPS in 2016, and is for students in grades 3-5. Students who are in person will take the assessment in person and those who are virtual will do so virtually. PARCC is scored on a scale from 1-5, with a 5 being "exceeds expectations." The school will be doing some preparation for the test to ensure students feel ready. To help prepare students, parents should encourage your students who will be taking PARCC. You might talk about the persistence and flexibility that they are developing. It's also important to give them the space

to talk about their emotions and to know it's okay to feel anxious and frustrated. The goal is to avoid test anxiety as much as possible.

PARCC does provide some student-level data to the school, but PARCC data is not used to dictate whether a child passes a grade or otherwise factor into their grading. The test is used to assess a school's educational progress.

There is no opt-out option for families. If there isn't a certain participation rate, there could be some penalties that the school might face. OSSE has been vague about repercussions. For example, they have said the school could face reduced funding. But, it is unclear what that might look like.

For those students who will take the test virtually, Assistant Principal Griffin explained that parents are not proctors during the testing. Students will be in virtual break out rooms testing on teams live with their teachers and will be able to chat with the teacher if they need help. OSSE is still developing guidance regarding the mechanics of testing. The school will also need to do test integrity training for parents so they are aware of what is and is not permissible during testing, as well as understand their role in the testing process.

Several parents shared a [Ward 6 Public Schools Parent Support Organization petition](#) that families can sign to urge OSSE to cancel PARCC this school year.

**Principal's Update:** Principal Payne-Chauvenet reminded families that the school is celebrating Kindness Week this week. Thanks to everyone who is participating in the activities.

Regarding PARCC, certain test scores will not affect teacher evaluations and pay this year. There is no in-person-learning update for now. Different options are being considered, and we don't know what things will look like for Term 4. To date, only in-person teaching staff have received an opportunity to receive vaccines. Some bigger schools have brought back large numbers of students, but it is important to remember that these schools are larger and therefore the total number of students they bring back will be larger than the number who have returned at Maury. School leadership expects to consult the Term 3 Reopening Committee as it prepares for Term 4. The Committee is comprised of the Principal and Assistant Principal, mandated positions like LSAT (Katie Spellacy and Jean Kohanek), WTU (Becca Sanghvi), Paraeducators (Angela Stover), PTA President (Ross Kyle), and Community representative (Elizabeth Nelson), and others including PTA Parliamentarian/Room Parent Coordinator (Ebony Burton), PTA SEL Committee (Caitlin Wesaw), school administration (Patrick Koontz), and additional teachers (Kim Wright-Spurlock and Camelia McCandies) and parents (Melanie

Anspacher, Margaret Ben-Or, Katherine Wright) to ensure representation for all grades.
